In consideration of being allowed to participate in any way in the QQLA Paddle (Kayak/canoe) Poker Run, I, as participant (the Releaser, hereby acknowledge, appreciate, and agree that:

1. The risk of injury from the activities involved in this program and while particular skills, equipment, and personal discipline may reduce this risk, the risk of injury does exist; and
2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE QQLA (THE RELEASEES) or other, and assume full responsibility for my participation; and
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the Releasees; and
4. I, for myself and on behalf of my heirs, assignees, personal representatives and next of kin, HEREBY RELEASE, INDEMINIFY AND HOLD HARMLESS THE QQLA, their officers, officials, agents, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessees of premises used for the activity WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law; and

I further stipulate and agree that the terms of this Agreement will apply to any minors accompanying me, that I am either the parent, legal guardian, or otherwise have direct and express permission from the minor's family for the minor to accompany me and for me to enter into this Agreement releasing the minor's

legal rights and/or remedies, that I assume all risk and responsibility for such minors in accompanying me, and that I agree to indemnify and defend the Releasees for any loss, liability, damage or cost they may incur due to the presence of the minor on kayak or canoe during this program, whether caused by the negligence of the Releasees or otherwise; and

6. I further stipulate and agree, that while participating in the kayaking or canoeing to be bound by all orders, rules and directions of the Releasees.

By signing this Release, I certify that I have read this Release and fully understand it and that I am not relying on any statements or representations made by the "RELEASED PARTIES."
